<u>Treatment and Corrections Report</u> – Ash – Hi all, as of this week I will be rotating out of the T&C position and Grace will be taking over. I have a family member that is very ill that I need to be with in another State and I don't know how long I'll be away for. I'm sure Grace will do a great job and continue to grow the T&C portfolio. Cyrenian House / Nannup Rehab: Meetings have been held every two weeks with AA members reporting good feedback. Bunbury and Busselton groups have been attending. I put an idea to Grace to get a member from each group, Bunbury and Busselton as a coordinator role of their group. A third group to be potentially started from Dunsbourgh & Margaret River meetings combined. The coordinator from each group would pick four members to go to the rehab on a rotating basis, meaning each group would go up once every six weeks. Sharing the rehab meeting amongst the district and lightening the work load for the T&C Person who has to find four people every two weeks currently. The

coordinator from each group would be in contact with Grace in regard to how the meetings are going and any concerns or literature needed for the meeting.

<u>Bunbury Men's Prison</u>: Meetings still held on weekly basis inside the by Father Brian. With strong numbers reported.

<u>Bunbury Psychiatric Unit:</u> After much effort from Grace and myself we have decided to discontinue pursuing a meeting at the Psychiatric Centre for the interim. The political wheels turn very slowly and hoops for potential attending members to attend was extensive.
