I am maintaining a current list of meetings with names, phone & email contacts, in Area B which is south of the line Swan River/ Gt. Eastern Highway east to the South Australian border. We currently have a total of 100 individual meetings in Area B. This is the breakdown:

As part of my position in the Peel District I have a letter drafted ready to send to 12 local high schools to discuss getting speakers back into schools. Have phoned and emailed all 12 schools and sadly have had no interest. But will give them another prod in the upcoming month.
